IP Address and Device Links How your personal information is collected This section describes how the above types of personal information are collected by us. Your personal information will be collected as follows: 1. Personal information obtained from you directly a. We will obtain information from you directly during the initial sign-up process including: i. Full Name, Email Address, Billing Address and Telephone Contact 2. Changes to the way in which we collect your personal information a. If we need to obtain personal information in relation to you from any other source than those described above, we shall notify you of this. How we use your personal information 1. General Purposes In general, your personal information will generally be processed for the following purposes: a. ID Verification during sign-up process Any sensitive information in relation to you will generally be processed for the following purposes: b. Fraud Prevention Fraud Prevention We will undertake fraud checks via use of your personal information. Fraud prevention checks are carried out regularly by the payment provider. This is to protect the customer, our own commercial interests (which is encompassed within our own legitimate interest as a business). Lawful basis for processing of your information We have described above the purposes for which we may process your personal information. These purposes will at all times be justified by UK data protection law. 1. General lawful bases The lawful basis upon which we are able to process your personal data are: a. Where have your consent to use your data for a specific reason; b. Where it is necessary to enter a legal contract with you or to perform obligations under legal contract with you; c. Where it is necessary to enable us to comply with a legal obligation. d. Where we need to protect your own vital interests (or the vital interests of another person) and/or In general, in order to meet the purposes, we have described above, we will process your personal information where we have your express consent on each occasion that the data is being processed. 2. Lawful bases applicable to sensitive information We have explained above that we may process sensitive information in relation to you. We have defined above the general purposes for which we process your personal sensitive information. These purposes are justified by lawful conditions. There are however additional conditions which apply to sensitive personal information. We will therefore only process your sensitive personal information for any or a combination fo the following additional lawful reasons, which are: a. Where you have provided us with explicit consent b. Where it is necessary for your vital interests or the interest of another person c. Where the processing is necessary for defending or establishing legal claims or court proceedings Sharing or your personal information None of your personal information is shared with any third party. We shall only permit the sharing of information to a third party with written consent from a client. We are required to enter into a formal legal agreement to enable such sharing to take place. How long your personal information will be kept Your personal information will only be kept for the period of time which is necessary for us to fulfil the above purposes. The use of personal information ceases after a client is no longer a paying subscriber to the service. Keeping your information secure We will ensure the proper safety and security of your personal information and measure in place to do so. We will also use technological and organisation measure to keep your information secure.

Children Our service is not intended for children (anybody under the age of 18). We do not intend to collect data from children.
